

## **Privacy Notice Israel**

Novartis Pharma AG, a company organized under the laws of Switzerland and located at Lichtstrasse 35, 4056 Basel, Switzerland, together with its affiliated companies being part of the Novartis Group of Companies as Novartis Hellas SACI, located at National Rd. No 1, 12th km, GR-144 51 Metamorphosis, Athens (collectively comprising “**Novartis**”), is responsible for the processing of your personal data. As the data controller, Novartis decides why and how data is processed, thereby acting as the “**controller**”. In this Privacy Notice, references to “**we**” or “**us**” means Novartis.

### **Specific personal data to be collected**

When you use the On Line Ordering, we collect your Personal Data (as defined below) that you shared with Novartis.

In this Privacy Notice, “Personal Data” means information that can be used to identify you, such as your name, email address and phone number. The types of Personal Data we collect will depend on the specific website function that you use. For instance:

- When you create an online account, we will collect your name, work email address, work address, and phone number.
- If you sign up for CTL019 patient order notification emails, we will collect the email address you provide to receive these alerts.

### **For which purposes does Novartis use your personal data and why is this justified?**

Novartis will use the collected information for the following specific purposes:

- To operate the On Line Ordering platform and support our business activities related to CTL019;
- To evaluate the effectiveness of the On Line Ordering;
- To conduct audits of the system and your use;
- To establish a log of data entries and verifications related to each product order;
- To monitor and prevent of fraud, infringement, and other potential misuse of the On Line Ordering
- For other internal business purposes
- For other purposes for which we have obtained your prior consent;

In addition, we will not process your personal data if we do not have a proper justification foreseen in the law for that purpose. Therefore, we will only process your personal data for any of the following purposes:

- the processing is necessary to perform our contractual obligations towards you/ the institution you represent

- the processing is necessary for our legitimate interests and does not unduly affect your interests or fundamental rights and freedoms

### **Who has access to your personal data and to whom are they transferred?**

Within Novartis:

- Novartis Pharmaceuticals Corporation, located at 1 Health Plaza, East Hanover, New Jersey, 07936, U.S.A. will have access to your data and T cells in order to manage the manufacturing process for CTL019.
- Novartis Pharma AG, located at Lichtstrasse 35, Novartis Campus CH-4056 Basel, Switzerland: Customer Service, Ordering and Scheduling and Quality functions as well as IT service (for IT support reasons) will have access to data in order to manage the ordering process and quality release process for CTL019.
- Novartis Apheresis Operations Staff located at either Novartis Pharma AG in Basel, Switzerland, and/or other Novartis's affiliates in Europe which includes Tissue Operations Experts and Apheresis Investigators will have access to the data, in order to investigate potential apheresis deviations and work on product requests with the Apheresis Collection and Cell Processing Sites.
- Novartis Pharma GmbH, located at Roonstraße 25, 90429 Nürnberg, Germany, will also manage both customer services and ordering processes and will be responsible for releasing the product for the EU Countries. will have access to your data in order to manage the process from ordering to supplying CTL019.
- Novartis Israel Ltd. relevant Qualified Person who is in charge of handling quality matters and releasing the product for use prior to its arrival to the medical center under Israel regulatory requirements. Such Qualified Person will have access to the data in order to manage the process from ordering to supplying CTL019.

We may share your personal data with the following third parties:

- Salesforce.com Inc., the Landmark@One Market Street, San Francisco CA 94105 US, will store your data in its database to be able to provide digital infrastructure (inter alia cloud storage) and IT systems on demand for the whole process;
- Fraunhofer-Gesellschaft zur Förderung der angewandten Forschung e. V., located at Hansastrasse 27 c, 80686 München, Germany ("FhG") as legal entity for Fraunhofer Institute for Cell Therapy and Immunology ("IZI") located at Perlickstrasse 1, 04103 Leipzig, Germany [which conducts [CTL019] manufacturing on behalf of Novartis;

Will have access to your data for manufacturing the product and storing the T cell and samples:

- Accenture AG, Fraumünsterstrasse 16, 8001 Zürich, Switzerland and Accenture HDC 4 – Mantri Cosmos SEZ, Nanakramguda Village, Gachibowli, Serilingampally Mandal, Randa Reddy District, Telangana 500008, India, will have access to data for IT support in its capacity as the system administrator

The above third parties are contractually obliged to protect the confidentiality and security of your personal data, in compliance with applicable law.

Your personal data can also be accessed by or transferred to any national and/or international regulatory, enforcement, public body or court where we are required to do so by applicable law or regulation or at their request.

The personal data we collect from you may also be processed, accessed or stored in a country outside the country where Novartis is located, which may not offer the same level of protection of personal data.

If we transfer your personal data to external companies in other jurisdictions, we will make sure to protect your personal data by (i) applying the level of protection required under the local data protection/privacy laws applicable to Novartis, (ii) acting in accordance with our policies and standards (iii) for Novartis located in Israel, the transfer of your personal data will be performed in accordance with the Protection of Privacy Regulations (Transfer of Information to Databases Outside the State's Boundaries), 5761-2001 and (iv) for Novartis located in the European Economic Area (i.e. the EU Member States plus Iceland, Liechtenstein and Norway, the "EEA"), unless otherwise specified, only transferring your personal data on the basis of standard contractual clauses approved by the European Commission or the Swiss Federal Data Protection and Information Commissioner respectively. You may request additional information regarding international transfers of personal data and obtain a copy of the protection measures implemented exercising your rights as detailed in this document.

### **How do we protect your personal data?**

We have implemented appropriate technical and organisational measures to provide an adequate level of security and confidentiality to your personal data.

These measures take into account:

- (i) the state of the art of the technology;
- (ii) the costs of its implementation;
- (iii) the nature of the data; and
- (iv) the risk of the processing.

The purpose thereof is to protect it against accidental or unlawful destruction or alteration, accidental loss, unauthorized disclosure or access and against other unlawful forms of processing. Moreover, when handling your personal data, we:

- only collect and process personal data which is adequate, relevant and not excessive, as required to meet the above purposes; and

The data is accessed and processed solely by the relevant personnel, under the responsibility of one of our representatives who is subject to an obligation of professional secrecy or confidentiality.

### **Data storage**

Novartis will retain your personal data for the period necessary for the manufacturing related data from product order to expiration of the shelf life of the final product + 10 years as per guidelines on data retention related to manufacturing records.

### **What are your rights and how can you exercise them?**

By using the On Line Ordering platform, you agree to all of the above. However, you may change your mind at any time and exercise the following rights in accordance and within the limits of the applicable law:

- the right to access your personal data as processed by us and, if you believe that any information relating to you is incorrect, obsolete or incomplete, to request its correction or updating;
- the right to request the erasure of your personal data or the restriction thereof to specific categories of processing;
- the right to withdraw your consent covering the use of your personal data at any time, without affecting the lawfulness of the processing before such withdrawal; and
- the right to object, in whole or in part, to the processing of your personal data.

In any case, you also have the right to file a complaint with the competent data protection authorities, in addition to your rights above.
